To Receive County, District and Community reports:

WSC - Cllr. Dawn Dicker;

- Cllr Dicker attended the official opening of the Mildenhall Hub.
- Newmarket Market is on the move again following safety issues although no site has yet been decided..
- A consultation is being carried out regarding taxi service in the district which now require all vehicles to be wheelchair enabled.

Planning Applications:

DC/21/1090/FUL - New timber sawmill with mezzanine and associated facilities (following demolition of existing storage building) LOCATION:

Herringswell Sawmills Kennett Road Herringswell IP28 6SS

Approval has been granted. However, Cllr Marchington was concerned to note that Highways, whilst acknowledging the PC's concern re passing places, no site visit was made and they used the images from Google Earth from 2010 to state they felt there were no issues on the passing places.

Highways/Footpaths & Trees:

Church Farm Barns (Telephone Kiosk) Flooding

- Following the report made by the Clerk it appears the drains were pumped out. Further photos have been taken showing that whilst there is some improvement, The Street is still flooding.
- The road sweepers have not been for some time despite having been told it should be on an 8-10 week cycle. When our Clerk is back from sick leave perhaps she can contact the Council. Cllr Dicker said she would look into it. Cllr Hicks expressed concern that the new drainage may get blocked with leaves now that autumn is approaching. Also, Cllr Brown said he would speak with Alan Nunn about making sure the grass cuttings are not left in The Street.

• The new drainage system for the bottle bank seems to be resolved.
